Regular Meeting April 15, 2019

Call to Order/Approval of the Agenda

President Wilson called the meeting to order at 6:00 p.m. Berryman moved and Thompson seconded to approve the agenda as presented. Motion carried 5-0.

Consent Agenda

Berryman moved and Schlutz seconded to approve the consent agenda consisting of the minutes of the March 18, 2019 regular meeting, the April 10, 2019 public hearing, the bills for approval and the March financial reports. Motion carried 5-0.

Meal Price Increases for 2019-2020 School Year

Thompson moved and Berryman seconded the motion to approve the following meal price increases for 2019-2020 school year. Increase lunch prices for PK-6 students from \$2.50 to \$2.60 per lunch and for 7-12 students from \$2.65 to \$2.75 per lunch. Increase breakfast prices from \$1.55 to \$1.65 per meal for PK-6 and from 1.65 to 1.75 per meal for 7-12 students. Adult meal prices will increase from \$3.65 to \$3.75. Adult breakfast will increase from \$1.80 to \$1.90 and an extra entrée from \$1.60 to \$1.70 as presented. Motion carried 5-0.

Approval of Cooperative Sharing Agreements with UNI and BVU

FY20 Classified Wage Increases & Assignments

Lee moved and Berryman seconded a motion to approve the FY20 Classified Staff wage increases and Assignments as follows: 1) Increase paraeducator/associate base pay \$1/hour to \$11/hour. Capped at \$20/hour. 2) Increase paraeducator/associate pay \$1.25/hour for 2019-2020. Eliminate the extra \$1/hour high needs pay. 3) Clerical, mechanic and foodservice would receive a 50 cent per hour increase.4) Salaried staff would receive a 2% increase apportioned individually. Motion carried 5-0.

FY20 Bus Driver Recommendations

Schlutz moved and Thompson seconded a motion to approve the bus driver recommendations as follows: 1) A 2% increase added to the daily rate in 2019-2020. 2) Eliminate bus route differential pay. 3) Remove extra trip minimum pay and increase hourly rate to \$12/hour. 4) Revise longevity pay to \$1 additional per day at 5 years of service, \$1.50 at 10, \$2 at 15 and \$2.50 at 20. Motion carried 5-0.

FY20 Administrative Wage Increases

Berryman moved and Lee seconded a motion to approve a 2% increase for the administrative staff as presented. Motion carried 5-0.

FY20 Nurse Contract

Schlutz moved and Lee seconded a motion to approve the FY20 Nurse Contract at a salary of \$36,525 as presented. Motion carried 5-0.
