The Louisa-Muscatine Public Schools Board of Education seeks the services of a qualified consultant to conduct a full and comprehensive search for a Superintendent of Schools who will start work on July 1, 2025.

Section II: Introduction

The Louisia-Muscatine Community School District is a rural public school district consisting of an elementary and a junior/senior high school along U.S. Highway 61 in Louisa County, Iowa. The district is named Louisa-Muscatine because it is in both Louisa and Muscatine counties. The district includes the cities of Letts, Grandview, and Fruitland as well as a portion of the city limits of Muscatine. The district was formed in 1959 as the consolidation of Letts and Grandview schools. The district has approximately 140 employees and 800 students. Louisa-Muscatine has a strong staff, engaged learners, and a supportive community.
